Governor Whitmer Issues Statewide "Stay Home, Stay Safe" Order

Effective at 12:01 am on March 24, 2020, for at least the next three weeks

Quickly recapping the advisory from this earlier today, **automotive repair and maintenance facilities can remain** open during the "stay home, stay safe" time frame.

At this time, the governor has stated that auto sales are closed. (See <u>FAO here</u> covering this.)

MADA and DADA continue to be in communication with the governor's team. As soon as we hear anything new, we will update dealers.
